Redwood Electric Board adopts resolution to assume responsibility of PUC

At its September 2017 board meeting the Redwood Electric Directors discussed and took action to adapt a resolution giving the Board authority in Distributed Generation rule making and dispute resolution. Because electric cooperatives are already locally controlled through their electric Boards, the legislature passed changes in statute removing duplicate regulation by the Minnesota Public Utility Commission. The cooperative must still follow state net metering statute. Rulemaking and dispute resolution will now go to the cooperative Board. The rules and information covering interconnection with Redwood Electric on a wind or solar project can be found on our website or by contacting our office.

Annual Elementary Fall Field Days for Area 4th Graders

Every year 4th graders from our area get the opportunity to make mud, hold worms, solve problems, and learn about safety at the Fall Elementary Field Day at the University of Minnesota's Southwest Research and Outreach Center.

Over the three day program almost 700 fourth graders rotate through seven educational presentations that include electrical safety, farm safety, soil science, corn production and usages, seed germination, composting with worms, and liquids, solids and gases.

Notice of Rights for Households of Military Service Personnel

The Minnesota Legislature has passed a law concerning disconnection, payment arrangements and appeals for electric service of military personnel who are issued orders into active duty, deployment or have a permanent change in duty station. Income criteria are specified by the law.



The receive this protection from disconnection, the residential member must request and reach agreement with the cooperative on a payment plan. Verification of income is required unless the customer is automatically eligible for protection against disconnection as a recipient of any form of public assistance including energy assistance that uses income eligibility in an amount at or below the income eligibility guidelines.

The residential member has the right to appeal when the cooperative and member are unable to agree of the establishment, reasonableness or modification of a payment schedule, or timeliness of payments under a payment schedule.

If denied, an appeal must be made within seven working days after the utility has deposited first class mail notice. Service cannot be disconnected during an appeal.

Leftover Turkey Noodle Casserole

Ingredients

4 c. (8 oz.) uncooked egg noodles
3 c. chopped leftover cooked turkey
1 (12 oz.) package frozen mixed vegetable, thawed and warmed
1 (10.5 oz.) can condensed cream of chicken soup
1 c. sour cream
1/3 c. milk
3/4 tsp. salt
1/2 tsp. pepper
1/4 c. shredded or grated Parmesan cheese
1 1/2 c. shredded mozzarella cheese, divided

Directions

1. Cook noodles in salted water according to package directions. Drain well.
2. While noodles cook, place condensed soup, sour cream, milk, salt, pepper, Parmesan cheese, and 1 cup shredded mozzarella in a large mixing bowl; stir until well combined. Add chopped turkey and mixed vegetables; stir to combine. Add hot drained noodles and stir to combine.
3. Spoon noodle mixture into greased 2-quart baking dish. Sprinkle the top with the remaining 1/2 cup shredded mozzarella.
4. Bake at 350 degrees for 25-30 minutes until heated through and the cheese is melty.

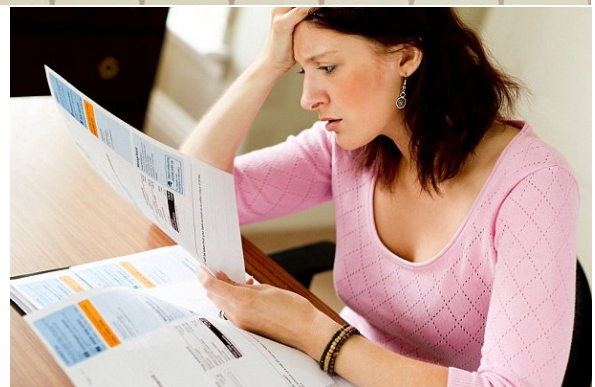

Your Electric Cooperative earns national grant to improve its cyber security plans

Redwood Electric Cooperative, along with four neighboring electric cooperatives, are part of a national program called the Rural Cooperative Cyber Security Capabilities Program (RC3).

The news headlines remind us of scary cyber security issues with Target, Russian hackers and most recently, Equifax. Rest assured, your electric cooperative and the electric industry in general, are involved in cyber security efforts to protect the national grid and your personal data. The cooperative's wholesale power suppliers participate in national annual cyber security tests and have procedures in place for monitoring, detecting and responding to cyber incidents. However, smaller electric cooperatives do not necessarily have a fulltime information technology (IT) person on staff. This is why the Department of Energy (DOE) awarded a grant to the National Rural Electric Cooperative Association (NRECA) to work with smaller cooperatives.

Redwood Electric Cooperative's department managers participated in a two day training session in September. Questions were answered about protecting member and employee personal data and operational equipment. Areas of focus included: identify, protect, detect, respond and recover. The co-ops response to each question provides a benchmark score so the co-op can record changes and document progress as its cyber security plan evolves.

"Cyber security requires a team effort" stated Dr. Cynthia Hsu, NRECA RC3 team lead. "More than 10,000 software vulnerabilities nationwide were discovered so far this year. We face challenges of embedded vulnerabilities in computer chips, malware & ransom ware and websites selling passwords. This involves understanding your vulnerabilities, risks and building layers of defense."

NRECA will take the feedback and general scores to develop a program that can be used with more electric cooperatives nationwide. The participating area cooperatives will receive two more follow-up training events slated for six months and a year from now.
