

Applicants must be a high school junior or senior (16-18 years old). The student's parent or guardian must be a member of Redwood Electric Cooperative.



Roasted Sweet Potato Bites with Guacamole

of green onion.

Ingredients:

- 4 sweet potatoes, sliced into 1/4" rounds
- 1 tablespoon extra virgin olive oil
- Salt and pepper
- 1 cup guacamole
- 1/4 cup fresh diced tomatoes
 - 1/4 cup sliced green onions

Preheat the oven to 400 degrees. Toss sweet potato rounds in olive oil and sprinkle with salt and pepper. Spread over a baking sheet and roast for 25 minutes, flipping once during cook time.

When potatoes are done roasted, remove from oven and top with a scoop of guacamole, a few diced tomatoes, and sprinkle

REC is obligated to provide information free of charge to all interested members upon request regarding rates and interconnection requirements. All interconnections require an application and approval to become a qualifying facility. Any dispute over interconnections, sales, and purchases are subject to resolution by the Cooperative.
