Annual Elementary Fall Field Days for Area 4th Graders

Every year 4th graders from our area get the opportunity to make mud, hold worms, solve problems, and learn about safety at the Fall Elementary Field Day at the University of Minnesota's Southwest Research and Outreach Center.

Over the three day program over 700 fourth graders rotate through seven educational presentations that include electrical safety, farm safety, soil science, corn production and usages, seed germination, composting with worms, and liquids, solids and gases.

CHICKEN ENCHILADA DIP

8 oz. cream cheese (softened)

1 tsp. hot sauce

What you should know about the new AMI meters...

- * REC lineman are installing the new automated meters in our rural service territory.
- * REC lineman will make an attempt to notify you once your new meter has been installed by either talking to you directly or by leaving this notice on your door.
- You will experience a brief power outage and may need to reset electronics.
- * The new meters will not affect your electric rate.
- * You will NO LONGER need to submit meter readings!!! Please note that your bills will look the

same (showing the boxes to enter readings) until all meters are changed out.

* If you have a sub meter and are on a load management program, you MUST keep the breaker turned ON for the metering system to work. If you no longer want to participate in the program, *please contact our office to discuss* <u>the options available.</u> Thank you!
